High Speed Two (HS2) is the new high speed railway for Britain.

### Being COVID-19 Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. ### What we are doing

We need to construct a temporary highway to the side of the current Harvil Road to allow us to start work on realigning Harvil Road later this year, and begin to build two over bridges over the Chiltern and HS2 rail lines.

From 13 February we start work to construct the tie-ins to the current highway. We will need to use construction vehicles in the highway, and to dig a trial hole. To do this safely we need to close the road fully.

### How this work might affect you

Harvil Road will be fully closed 24 hours a day from 13 to 21 February inclusive.

A diversion will be in place via Moorhall Road / A412 / A40 and will be clearly marked.

The location of the closure and the diversion is shown on the next page.

Access to the Dogs Trust will be maintained throughout the works.

### Duration of works

13 to 21 February.

The working hours will run for 24 hours each day to reduce the closure of the road to one week

Harvil Road will be fully closed 24 hours a day

We will use lights as needed and we will ensure that these will face the work areas only

### What we will do

We will ensure that the diversion is clearly marked throughout

Access to the Dogs Trust will be maintained throughout the road closure

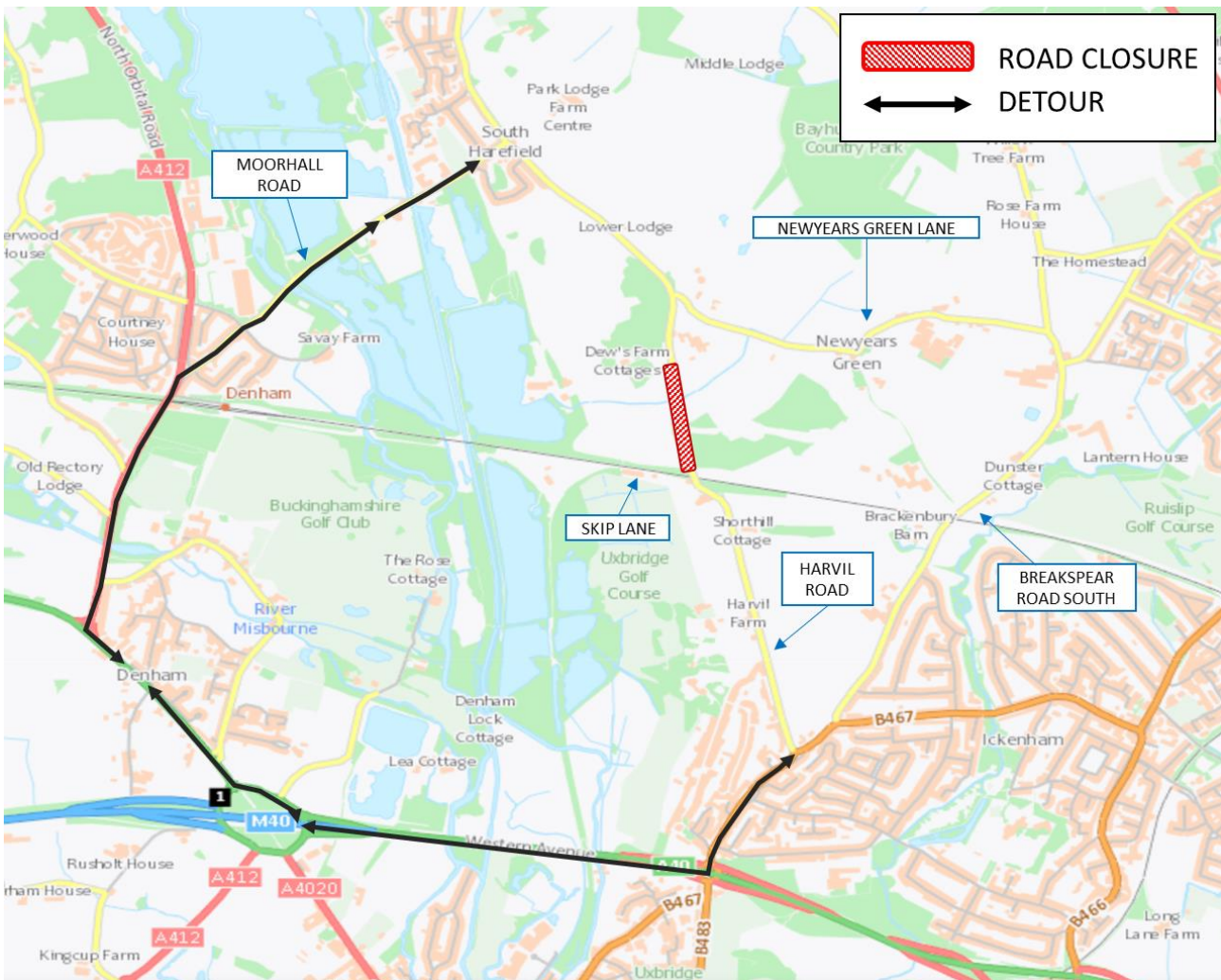
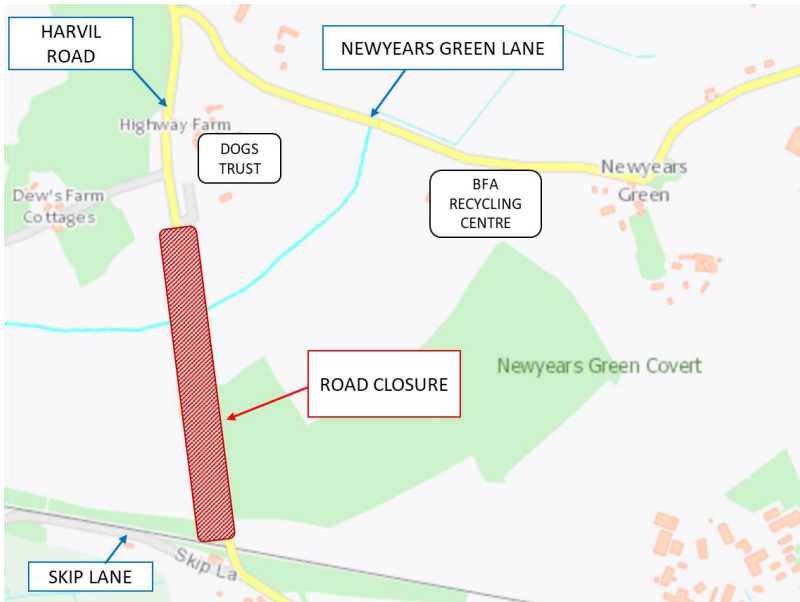
Access will be permitted to the residences north and south of the road closure
